- Current Budget- Revised budget is really \$48,161 (due to increase in student population and possibly increase in amount of money allocated)

- Extra \$2,000 in Substitutes for PD (during school year) Extra \$1,500 Registration for PD (during the summer)
- \$2,000 more in supplies for intervention aides and the work they do
- As of 11-1-15 we have spent \$29,418 of our 2015-2016 Budget
