Continue to Review School Data: Mrs. Law SAGE presentation (Added by Matt Barber) Data Analysis Overview of SAGE/To inform your conversation with facts 385 students grades 3-5 participated in SAGE 11% ethnic minorities 1% ELL 3% Special Ed Services See attached PowerPoint for more information – conclusions from Mrs. Law's data presentation: Draper ES did very well on the SAGE in all areas (ELA, Math, and Science) when compared to district, state, and

comparable school data. Conclusions from Mrs. Law's data presentation: Draper ES did very well on the SAGE in all areas (ELA, Math, and Science) when compared to district and state data. Our language and math scores compare very well to similar schools while the science scores lag somewhat. Science scores do vary by classroom with some still performing well above comparable schools.

### SCC Member Questions after the presentation:

How does opt out effect us at Draper ES? 2015-4 (students), 2016-7 (students) Why is the test adaptive? It allows us to have a value added (growth) piece based on individual baseline data. Students are put into data cohorts and an algorthim is used to determine a growth percentile. that has an algorithm (that is very confusing). One is a data cohort.

Begin to Review and Analyze School Land Trust Plans on state website (when they are available)

- Scope of fund use
- Timeline and plan development (flowchart)

State website is under construction; we can not look at other school's plans. We hope to next year, at our January meeting.

We did discussed where the LandTrust \$ can be spent: items that directly impact student acheivement. Technology and Aides are two places where money is used most often.

#### Digital Citizenship Action Plan: Mrs. Preece presentation and vote

We want to become a Digitally Certified school as part of the plan we need a vision, professional development, and communication with parents (at least 3 times per year). We must show that we are training our students in digital citizenship. We will be focusing on grades 3-5. 10-12 within the school year lessons will be taught, during Brain Boosters, teaching the students Common Sense lessons about using the Internet. Common Sense Media is the website being used to help create these lessons for our students. This website also gives dates and deadlines for each item. The district has helped schools lay out a plan for becoming Digitally Certified, including due dates and deadline for each required item.

What is the "reward" for being a Digitally Certified school? CSD wants to become a Certified District, and we get students who are internet savvy and safe.
