Our land trust money is in a good place. Only ones required to be at school are Christy, Fano and Marion. But Marion is part of an at risk population, so she will be limited. The district is allowing Aides to be paid during leave so that will still be a cost.

(Same goals for Land Trust and TSSA)- We can't tie money to anything without a goal, so we have goals for Math, ELA, and Science.

In ELA about one fourth of students are not proficient. Our goal is to have an 8% improvement school-wide.

32% of students are not proficient in RISE. 19% are not proficient in math according to Accadence We have a goal to increase proficiency in this area by 8% as well. Rise Science measures that 35% of our students are not proficient. Our goal is for 90% percent of teachers to be using the new science standards using adherence to the indicators.

School Climate Goal- There is a measure of 38% internal and 27% external at-risk behaviors. We are going to focus on restorative practices and Second Steps social emotional learning curriculum. We are going to measure with check lists and walk through observations.
