Meeting Minutes

Business Items:

1. Welcome Janene
2. Approve Previous Meeting Minutes Janene
 - a. [September 12 Meeting Minutes](#)
 - b. Mike motioned to approve the minutes. It was seconded by Megan. The minutes were unanimously approved by those present who attended the previous meeting.
3. Review Acadiance Data Ronnie
 - a. Ronnie said that tomorrow some embargoed information will be coming out
 - b. 4 areas of a report card will be coming out (each receiving a grade). All based on RISE testing (3-5th grades)
 - i. Achievement -37%
 - ii. Average Growth 37%
 - iii. Lowest 25% Growth - 17%
 - iv. ELL progress (not a part of RISE) - 9%
 - c. They also taken into consideration early literacy and attendance
 - d. Ronnie shared the Gateway which compares Draper Elementary to like schools across the state
 - i. This data shows proficiency

- iv. We underperformed in our growth. Ronnie talked to her staff about this. This means we need our high performers to be making typical growth in addition to our low performers. Everyone needs to be making growth.
- v. Ronnie said there is a lot to celebrate and a lot to focus on. She will be speaking with each grade level team to see how they plan to track growth this year.
- vi. In the report card coming out we dropped in areas 1 & 3 and went up in 4 and went up in early literacy
- vii. Ronnie said there was a significant drop in attendance.
 - 1. Angie asked how we compared to other schools. We are below district average.
 - 2. Nancy indicated she doesn't think it is a fair assessment since students were encouraged not to attend if they were sick.
 - 3. Morgan said she thinks that it was abused by people as well. Families were taking long family vacations.
 - 4. Ronnie indicated that she thinks it is important to support families who want to travel and create memories. However, seat work can not be made up or replaced so it is something to be aware of and look into.
 - 5. Brooke asked can you see the demographic of who was missing. Older kids (other schools) had it easier to miss as well.
 - 6. Ronnie said she is not here to alarm but to create attendance and come up with a plan to create awareness in the community.
 - 7. Stacey said if our numbers were doing well that the attendance wouldn't matter as much, but since our numbers are more concerning we should be concerned about attendance.
- viii. When the information comes out, I would encourage you to come sit down with me (Ronnie) to discuss specifics released in the data.
 - 1. Angie suggested a separate meeting to go through the data so Ronnie could go over the data with multiple SCC members at the same time.
 - 2. Ronnie reminded us that this is a snapshot.
 - 3. Stacey asked what would be good for our SCC and what would be good to share with the parents. Janene expressed worry about protecting teachers as we discuss data with parents. Angie said it would be important to help parents understand the attendance component.

 - i. Last years safety plan was reviewed
 - 1. **#1 School Safety Concern:** Safe walking at the north east corner of 12650 S and Fort Street
 - 2. **Other Primary Concern:** We would like to have parent safety tips sent home occasionally to parents
 - 3. **Action Plan:** We have a member who is in contact with the city. We will also put the concern on our Safe Walking Route that will be turned in after the first of the year.
 - ii. Digital citizenship week is next week.
 - iii. Janene said last year's plan needs to be moved on. We got news that a new sidewalk will be going in on Fort Street in 2026. We are not going to be able to get anywhere with the city. Stacey agreed that it is our biggest safe walking route concern but not necessarily our biggest school safety concern.
 - iv. Jamie asked what percentage of students walk to school. Janene said more would walk if it was safer. Jamie goes to the bus stop every morning and thinks that basic bus safety is an issue. Kids are racing the bus. Mike asked why the bus driver doesn't yell at them. The transportation on the buses is not a very safe environment (due to language). Bullying is a concern.
 - v. Melissa said we are looking for an action plan.
 - vi. Janene said she is concerned that anyone could just walk on the playground.
 - vii. Stacey said she has a list from 3 years ago of safety concerns.
 - viii. Morgan said something she has noticed is that there are students that aren't wearing helmets. It is something they have talked about in the PTA. More parents need to be aware that students need to be wearing helmets.
 - ix. Ronnie said we really want to focus on one thing per year.
 - x. Stacey said it wouldn't hurt to explore each area.
 - xi. Melissa asked if we wanted to poll parents on their opinions. Mike indicated that is why we have been elected as an SCC.
 - xii. The school has changed a lot this year to address the social emotional climate.
 - 1. Angie asked what is the update?
 - 2. Ronnie said focus on Tier 1 Character Ed theme of the month - morning announcements, school social worker reads a book to each grade, morning meetings

- xiii. Melissa wondered if we could address transportation as a whole. Jamie said could it be addressed as school safety tips.
- xiv. Julie asked how many bikes vs walks vs bus - exact info is unknown but we can look at who is assigned a bus
- xv. Jamie is recommending school safety tips. Ronnie asked could we do a school safety month. If it is every month all year, that is too much for Ronnie and Janene to just take on.
- xvi. Stacey said what if we go with our climate as our goal and then on the side also start some school safety tips.
- xvii. How are we getting it to parents? Website? Social media? Jamie said she works in marketing and they took a poll about how students found out about an event and everyone found out from a different channel. We need a wide variety to access all parents.
- xviii. Ronnie asked us to refocus on what our focus will be and less details on specifics.
- xix. Janene recommended working on it for the spring.
- xx. Angie revisited bus safety concerns. Her kids also do not like the behaviors they see on the bus. Can we contact the district about training? Do they need a second adult? Can we have an incentive program? Is there a way to support bus drivers? Ronnie said they are 24 bus drivers still down. Hiring an aide was not an option. But we could train the kids on how to act on the bus. Ronnie said the biggest thing is the kids.
- xxi. Ronnie said they could add the bus to the FIRE focus.
