### Digital Citizenship

# Safe Walking Route

Principal Mulqueen shared an update regarding the proposed crosswalk connecting the school to the new development across the street. At this time, the city has not provided a concrete plan regarding the timing, location, or design of the crosswalk.

The development is not yet halfway complete, so the crosswalk is unlikely to be installed in the near future.

## Land Trust & TSSP

### Staffing and Support

A new math aide is working primarily with 4th and 5th grade students, and occasionally with 3rd grade. This aide is a former 6th grade teacher and is being utilized for both extension and intervention support.

### Budget Update

Principal Mulqueen shared that the district recently transitioned to a new financial system. A detailed budget breakdown will be available next month to assess whether spending is on target.

### Academic Data Review

- **RISE Assessment (Grades 3–5)**

Data from April 2025 shows the school ranked 25th in the state, with upward movement in rankings.

The Science section of the test presents challenges, as its format differs from students' daily learning experiences. Teachers will continue using practice questions to help students become more familiar with the test structure.

- **Curriculum Changes**

The state is updating curriculum standards. Our district is adopting a new curriculum next year, including a new math program. There will be a strong focus on math instruction.

- **Math Performance and Goals**

Data indicates students struggle with recall of math facts, which impacts overall performance.

The school is developing a plan to increase math fact practice, including:

- Exploring new programs to support math fact fluency
- Expanding use of the existing Building Fact Fluency (BFF) kits
- Considering intervention pull-outs with the new math aide
- Reviewing last year's goal focused on computation to help guide next year's math goal (computation vs. composite score)
